ORDINANCE NO. 16-2005

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE
BOROUGH OF RIVERTON, IN THE COUNTY OF BURLINGTON, NEW
JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 123-30,
SCHEDULE VIII, TO DESIGNATE ADDITIONAL THROUGH STREETS
IN THE BOROUGH OF RIVERTON**

WHEREAS, the Mayor and Council of the Borough of Riverton, (the “Borough”) have previously requested the Department of Transportation to investigate the feasibility of designating certain streets as through streets in the Borough of Riverton; and

WHEREAS, the Department of Transportation, Traffic Investigations Section, have conducted a field investigation, and by the attached letter of August 30, 2005, have approved the designations of Thomas Avenue, Linden Avenue and Elm Terrace as through streets in the Borough of Riverton,

NOW THEREFORE, BE IT ORDAINED AND ESTABLISHED BY THE MAYOR AND THE COUNCIL OF THE BOROUGH OF RIVERTON, COUNTY OF BURLINGTON, STATE OF NEW JERSEY THAT:

Article VIII, Chapter 123-30, Schedule VIII, Through Streets, be amended and supplemented as follows:

SCHEDULE VIII, THROUGH STREETS

I. Pursuant to the provisions of N.J.S.A. 39:4-140, the streets or parts of streets described are hereby designated as Through Streets. Stop signs shall be installed on the near-right side of each street intersecting the Through Street except where Yield signs are provided for in the designation.

Name of Street

Limits

Thomas Avenue

Between South Broad Street and the Riverton Borough corporate line - Cinnaminson Township corporate line

Linden Avenue

Between South Broad Street and Park Avenue

Elm Terrace

Between South Broad Street and Park Avenue

II. This Ordinance shall take effect upon its adoption in accordance with law.
