ORDINANCE NO. 17 - 2005

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE
BOROUGH OF RIVERTON, IN THE COUNTY OF BURLINGTON,
NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER
123 OF THE RIVERTON BOROUGH CODE RELATIVE TO
SCHEDULES FOR ONE WAY STREETS IN THE BOROUGH OF
RIVERTON**

WHEREAS, the Mayor and Council of the Borough of Riverton, (the “Borough”) have received a recommendation from the Burlington County Engineer relative to a traffic study performed by Burlington County; and

WHEREAS, the traffic study has been performed in accordance with a grant from the Safe Routes to Schools Program; and

WHEREAS, the Chief of Police of the Borough has made various recommendations concerning the additional designation of one-way streets in the Borough contiguous to the Riverton Public School or playground,

WHEREAS, the Borough Engineer has concurred in the study performed by the Burlington County Engineers,

**NOW THEREFORE, BE IT ORDAINED AND ESTABLISHED BY THE
MAYOR AND THE COUNCIL OF THE BOROUGH OF RIVERTON, COUNTY
OF BURLINGTON, STATE OF NEW JERSEY THAT:**

I. Chapter 123-29, Schedule VII: One-way streets be amended and supplemented as follows:

CHAPTER 123-29: ONE-WAY STREETS

<u>NAME OF STREET</u>	<u>DIRECTION</u>	<u>LIMITS</u>
Howard Street	Northwest	Between Fifth Street and Fourth Street
Cinnamson Street	Southeast	Between Fourth Street and Fifth Street

II. This ordinance shall take effect upon immediate adoption.
