ORDINANCE NO. 10-06

**AN ORDINANCE OF THE BOROUGH OF RIVERTON, IN THE
COUNTY OF BURLINGTON, NEW JERSEY, AUTHORIZING A
SPECIAL APPROPRIATION FOR THE PREPARATION AND
EXECUTION OF A COMPLETE REVALUATION PROGRAM IN
THE BOROUGH OF RIVERTON**

WHEREAS, the Mayor and Council of the Borough of Riverton have received bids for the conduct of a complete revaluation program in the Borough of Riverton; and

WHEREAS, the Mayor and Council of the Borough of Riverton have agreed to award a contract to Vital Services Group, in the amount of \$69,900; and

WHEREAS, it has been found necessary to make an emergency appropriation to meet certain extraordinary expenses to be incurred for Revaluation Services; and

WHEREAS, N.J.S.A. 40A:4-53 provides that a municipality may adopt an ordinance authorizing a special emergency appropriation for the purpose of preparing and executing a complete revaluation program; and

WHEREAS, N.J.S.A. 40A:4-53 provides that it shall be lawful to make such appropriation, which appropriation and/or the special emergency notes issued to finance the same shall be provided for in succeeding annual budgets by the inclusion of an appropriation of at least one-fifth or one-third of the amount authorized pursuant to this Act,

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Riverton in the County of Burlington (not less than two-thirds of all the members thereof affirmatively concurring) that in accordance with the provisions of N.J.S.A. 40A:4-55:

1. An emergency appropriation be and the same is hereby made for Revaluation Services in the total amount of \$69,000.

2. That said emergency appropriation shall be provided for in full in the budgets of the next succeeding years by the inclusion of not less than \$13,980 in each of the next five succeeding annual budgets.

3. This Ordinance shall take effect upon immediate adoption.
