**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE  
BOROUGH OF RIVERTON, IN THE COUNTY OF BURLINGTON,  
NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER  
123 OF THE RIVERTON BOROUGH CODE RELATIVE TO  
SCHEDULE I: NO PARKING**

**WHEREAS**, the Mayor and Council of the Borough of Riverton, (the “Borough”) have received a recommendation from the Chief of Police of the Borough of Riverton concerning the establishment of a no parking zone in the 600 Block of Lippincott Avenue in the Borough; and

**WHEREAS**, the Chief of Police of the Borough of Riverton has recommended the establishment of a no parking zone on the southwest side of Lippincott Avenue from Harrison Street to South Broad Street in order to provide for the orderly passage of traffic;

**NOW THEREFORE, BE IT ORDAINED AND ESTABLISHED BY THE MAYOR AND THE COUNCIL OF THE BOROUGH OF RIVERTON, COUNTY OF BURLINGTON, STATE OF NEW JERSEY THAT:**

**I. Chapter 123-23, Schedule I: No parking** be amended and supplemented as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Lippincott Avenue	Southwest	Between Harrison Street and South Broad Street

**II.** This Ordinance shall take effect upon immediate adoption
