ORDINANCE NO. 2009 - 8

**ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 26-16
OF THE RIVERTON BOROUGH CODE TO DELINEATE DUTIES,
RESPONSIBILITIES AND QUALIFICATIONS OF THE CHIEF OF
POLICE**

WHEREAS, the Public Safety Committee of Riverton Borough Council has recommended that specific duties, responsibilities and qualifications be enumerated for the position of Chief of Police of the Riverton Police Department; and

WHEREAS, the Mayor and Council of the Borough of Riverton have reviewed the attached addendum which delineates the duties, responsibilities and qualifications of the Chief of Police of the Riverton Police Department; and

WHEREAS, these duties, responsibilities and qualifications are to supplement any of the statutory requirements of the Chief of Police as set forth in N.J.S.A. 40A:14-118 and Chapter 26 of the Riverton Borough Code;

NOW THEREFORE BE IT ORDAINED AND ESTABLISHED by the Mayor and Council of the Borough of Riverton, County of Burlington, State of New Jersey, that Chapter 26, Article VI of the Riverton Borough Code be amended and supplemented as follows:

I. §26-16 of the Code of Riverton Borough be amended and supplemented as follows:

The Rules and Regulations contained in a document entitled "Police Department of the Borough of Riverton Rules and Regulations, County of Burlington, State of New Jersey," dated November 14, 2002, shall be and are hereby amended to include the attached addendum A which sets forth the duties, responsibilities and qualifications of the Chief of Police of the Borough of Riverton.

II. If any section, sentence, clause, provision or portion of this ordinance shall be held to be invalid by any Court of competent jurisdiction such holdings shall not effect or impair any other sections, sentences, clauses, provisions, or portions of this ordinance.

III. This ordinance shall become effective upon final adoption in the manner prescribed by law.
