**AN ORDINANCE OF THE BOROUGH OF RIVERTON RESCINDING  
THE EXISTING RULES AND REGULATIONS OF THE RIVERTON  
POLICE DEPARTMENT, DATED NOVEMBER 14, 2002, AND  
SUBSTITUTING THE NEW RULES AND REGULATIONS OF THE  
RIVERTON POLICE DEPARTMENT, DATED JULY 13, 2011**

**WHEREAS**, the Mayor and Council of the Borough of Riverton had previously adopted rules and regulations for the Police Department of the Borough of Riverton by Ordinance 8-02, which were effective November 14, 2002; and

**WHEREAS**, the Public Safety Committee has recommended that the existing rules and regulations be replaced with the attached rules and regulations of the Riverton Police Department, dated July 13, 2011;

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council:

**I.** Ordinance 8-02, which adopted the rules and regulations of the Police Department of the Borough of Riverton effective November 14, 2002, be and is hereby rescinded.

**II.** **CHAPTER 26, ARTICLE VI** be and is hereby amended as follows:

**ARTICLE VI. Rules and Regulations**

**§26-16. Rules and regulations adopted.**

The rules and regulations contained in a document entitled Riverton Borough Police Department Rules and Regulations, which document is dated July 13, 2011, are hereby officially adopted and made a part of this chapter. These rules and regulations will be incorporated in attachment 1 to this chapter with Addendum A, which sets forth the duties, responsibilities, and qualifications of the Police Chief.

**III.** If any section, sentence, clause, provision or portion of this ordinance shall be held to be invalid by any Court of competent jurisdiction, such holdings shall not affect or impair any other sections, sentences, clauses, provisions or portions of this ordinance.

IV. This Ordinance shall become effective upon final adoption and publication in the matter prescribed by law.
