ORDINANCE NO. 2011 - 7

AN ORDINANCE AMENDING CHAPTER 24, ARTICLE III, SECTION 24-5 OF THE CODE OF THE BOROUGH OF RIVERTON TO RESCIND SECTION 8.5A OF THE EMPLOYEE HANDBOOK RELATIVE TO LONGEVITY PAYMENTS TO EMPLOYEES OTHER THAN POLICE

WHEREAS, the Mayor and Council had previously passed a resolution authorizing Longevity Payments for all full time Borough employees not covered by a Collective Bargaining Unit per resolution number 24-95 which was subsequently amended by resolutions 86-97 and 49-00;

WHEREAS, the Resolution 24-95 stated that the Borough Council would annually review the issue of longevity; and

WHEREAS, the Borough's financial ability to fund these payments has changed since the initial resolution was passed; and

WHEREAS, the Mayor and Council agree with the recommendations of the Finance Committee to no longer offer these additional payments to Borough employees not covered by a Collective Bargaining Agreement; and

WHEREAS, this amendment is authorized by, and subject to, the provisions of N.J.S.A. 40A:9-165;

NOW THEREFORE BE IT ORDAINED by the Mayor and Council that;

I. Chapter 24, Article III, §24-5 be amended as follows:

1. §8.5A of the Borough Handbook be and is hereby rescinded.
2. Resolutions 24-95, 86-97 and 49-00 are hereby rescinded.

II. This Ordinance shall become effective upon final adoption and publication in the matter described by law.
