ORDINANCE 7 - 2015**

**ORDINANCE AUTHORIZING A ONE-TIME SALARY ADJUSTMENT
TO THE CHIEF OF POLICE FOR DUTIES PERFORMED FOR
ADDITIONAL HOURS SERVED IN 2015 WITHIN A 3-MONTH
PERIOD**

WHEREAS, the Riverton Police Department was undermanned during 2015 resulting in the Chief of Police having to perform additional duties, which included, but was not limited to, covering shifts, performing additional investigative and administrative duties during the certain months in the year 2015; and

WHEREAS, the actions of Chief John Shaw during this period contributed to the health, safety and well being of residents of the Borough of Riverton, and

WHEREAS, the Mayor and Council wish to recognize the many worked hours including totals of 288 hours in September, 252 hours in October, and 204 in November.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Riverton:

1. That Chief John Shaw be and is hereby compensated in the amount of six thousand seven hundred dollars (\$6,700) noting this one time increase is within the prescribed Salary Ordinance 3-2015;
2. That this is a one-time increase which represents payment for Chief John Shaw's dedication and performance above and over and above his regular duties and hours as Chief of the Riverton Police Department.
3. This ordinance shall take effect 20 days after final passage, as prescribed by law.
