**ORDINANCE NO. O-2016-06**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 123 OF  
THE CODE OF THE BOROUGH OF RIVERTON, COUNTY OF BURLINGTON,  
STATE OF NEW JERSEY TO INCREASE PENALTIES FOR CHAPTER  
VIOLATIONS, TO ADD ADDITIONAL AUTHORIZED VEHICLE ONLY AND  
NO PARKING ZONES, AND TO REMOVE CERTAIN PARKING TIME LIMITS  
AND LOADING ZONES**

**WHEREAS**, the Council of the Borough of Riverton (“Borough”) believe that certain changes to existing parking and loading zones, parking time limits, and penalties for chapter violations will better facilitate the flow of traffic through the Borough; and

**WHEREAS**, through this ordinance, the Borough wishes to amend and supplement Chapter 123 of the Borough’s Code entitled “Vehicles and Traffic” to add an increased financial penalty for chapter violations, add additional authorized vehicle only and no parking zones, and to remove certain parking time limits and loading zones.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Borough Counsel of the Borough of Riverton, County of Burlington, and State of New Jersey as follows:

**SECTION 1.** Section 123-5 of the Code of the Borough of Riverton shall be amended and revised to read as follows:

Unless another penalty is expressly provided by New Jersey statute, every person convicted of a violation of a provision of this chapter or any supplement thereto shall be liable to a penalty of not more than \$100.00.

**SECTION 2.** Chapter 123 of the Code of the Borough of Riverton is hereby amended and revised to add a new Section 123-11.3 which shall read as follows:

123-11.3: Locations where vehicle use shall be prohibited. No person shall operate or park any vehicle at the following locations:

<b>Name of Street</b>	<b>Location</b>
Fulton Street	Second Street to the bank of the Delaware River
Riverton Memorial Park	Beyond the 8 <sup>th</sup> Street Parking Lot and beyond the tennis court parking lot.

**SECTION 3.** Schedule I of Section 123-23 of the Code of the Borough of Riverton shall be amended and revised to add one (1) additional “No Parking” streets as follows:

<b>Name of Street</b>	<b>Sides</b>	<b>Location</b>
Fulton Street	Both	Second Street to the bank of the Delaware River

**SECTION 4.** Schedule IV of Section 123-26 of the Code of the Borough of Riverton is hereby amended and revised to delete in its entirety:

<b>Name of Street</b>	<b>Sides</b>	<b>Hours</b>	<b>Maximum Time (Minutes)</b>	<b>Location</b>
Main Street	Southwest	8:00 a.m. to 6:00 p.m.	120	From North Broad Street to a point 400 feet west thereof.

**SECTION 5.** Schedule IX of Section 123-31 of the Code of the Borough of Riverton is hereby amended and revised to add two (2) additional stop intersections as follows:

<b>Stop sign on</b>	<b>At Intersection of</b>
7 <sup>th</sup> Street	Cinnaminson Street
7 <sup>th</sup> Street	Lippincott Avenue

**SECTION 6.** Schedule XI of Section 123-33 of the Code of the Borough of Riverton is hereby amended and revised to delete in its entirety:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>	<b>Time</b>
Howard Street	Northeast	From the southeast line of Borough Hall parking lot 64 feet east	8:00 a.m. to 6:00 p.m. Monday through Friday

**SECTION 7.** Should any section, subsection, paragraph, sentence, clause or phrase of this ordinance, or its application be declared unconstitutional or invalid for any reason, such decision shall not effect the validity of the remaining portion of this ordinance, or its application to any other person or set of circumstances.

**SECTION 8.** Effective Date. This ordinance shall take effect upon final passage and publication in accordance with the law.

**SECTION 9.** All other ordinances or parts of ordinance inconsistent herewith are hereby repealed.
