AND BASEBALL FIELDS AT RIVERTON MEMORIAL PARK**



**WHEREAS**, the Park and Recreation Advisory Committee has recommended a schedule of fees for the usage of these fields by organizations;



**Riverton Memorial Park**  
**2014-15 Field Use Fee Schedule (Effective August 1, 2014)**

All fees will cover the maintenance of the infields and/or grass areas of the park. These fee schedules are based on use and historical damage, as follows:

**BASEBALL**

**Babe Ruth Field (U-18)**

- Single use per week – 1 game or 1 practice per week \$300 per season
- Twice per week use – any combination of games/practice \$400 per season
- Greater than twice per week – any combination \$500 per season

**Babe Ruth Field (18+)**

- Single use per week – 1 game or 1 practice per week \$400 per season
- Twice per week use – any combination of games/practice \$500 per season

**Majors (11-12 years old) Field**

- Single use per week – 1 game or 1 practice per week \$250 per season
- Twice per week use – any combination of games/practice \$300 per season
- Greater than twice per week – any combination \$450 per season

**Other Fields**

- Single use per week – 1 game or 1 practice per week \$150 per season
- Twice per week use – any combination of games/practice \$200 per season
- Greater than twice per week – any combination \$350 per season

**Multiple Field Use**

- Use of All fields for spring season \$750 per season
- Use of All fields for fall season \$300 per season

**Varsity Baseball**

- Use of Babe Ruth field – spring season \$500 per season
- Use of Babe Ruth field – fall season \$250 per season

**SOCCER**

Soccer use will be limited to the fall season to provide some “rest” for the grass areas. There is currently no extra field time available in the fall season.

**Soccer Clubs**

- Use of All fields for fall season \$750 per season
- Use of All fields use for spring season (no practice) \$300 per season

Every field user is expected to leave the field in “game ready” condition, i.e. infield raked, all holes or depressions filled and tamped. (Baseball: batters boxes, pitcher’s mound and base areas are of primary concern) Player bench areas are to be clean and free of trash and debris.

- Spring Season = January through May
- Summer Season = June and July – Fee schedule is 40% of full season fees.
- Fall Season = August through December

## PARKS, PLAYGROUNDS AND RECREATIONAL AREAS

§ 92-1. Applicability.

§ 92-2. Authority to adopt regulations.

§ 92-1. Applicability.

The rules and regulations promulgated herein shall apply to all public parks, playgrounds and recreational areas.

§ 92-2. Authority to adopt regulations.

The Borough Council may, from time to time, by resolution, adopt such regulations as it may choose to facilitate the effective operation and control of all parks, playgrounds and recreation areas under its jurisdiction.

**§ 92-3. Prohibited acts.**

- A. It shall be unlawful for any person on borough property, as contemplated by § 92-1 hereof, to:
- (1) Use threatening, abusive or insulting language.
  - (2) Do any obscene or indecent act.
  - (3) Throw stones or other missiles.
  - (4) Play or practice golf. [Amended 11-9-1995 by Ord. No. 13-95]
  - (5) Interfere with, encumber, obstruct or render dangerous any public way, path, walk, bridge or public place.
  - (6) Do any act tending or amounting to a breach of the peace.
  - (7) Climb or stand upon any fence, shelter, seat, bridge railing or support, statue or other erection other than play structures. [Amended 11-9-1995 by Ord. No. 13-95]
  - (8) Introduce, carry or fire any firecrackers, torpedoes or fireworks.
  - (9) Engage in, instigate and/or encourage a contention or fight.
  - (10) Assault any person.
  - (11) Participate in betting, gambling, gaming or use or operate any slot machine or gaming table or other gambling instrument or sell fortunes.
  - (12) Solicit gifts or contributions for any purpose without permission of the Borough Council.
  - (13) Possess, use or be under the influence of intoxicating alcoholic beverages. [Amended 11-9-1995 by Ord. No. 13-95]

- (14) Possess, use or be under the influence of drugs as defined and prohibited by the New Jersey Revised Statutes.
- (15) Give entertainment of any kind or transact business of any kind or hold public meetings or assemblies without permission of the Borough Council.
- (16) Occupy a camp or campground or sleep overnight without permission of the Borough Council.
- (17) Sell, vend or give away any article of merchandise or other matter or distribute handbills or circulars without permission of the Borough Council.
- (18) Kindle, build, maintain or use a fire except in fireplaces provided or in an approved container.
- (19) Post, paint or affix or erect any sign, advertisement, banner or any other matter for attracting attention without permission of the Borough Council.
- (20) Possess or use guns, knives, slingshots or other dangerous weapons.
- (21) Possess or use any explosive materials that may cause an explosion when used either alone or in combination with some other material to produce rapid flaming combustion or administer a destructive blow to surrounding objects.
- (22) Kill, injure or disturb any animal or bird or damage any grass, tree, shrub or plant or any building, sign structure or equipment upon any premises under the jurisdiction of the borough.
- (23) Ride, drive or bring any horse upon any borough property as contemplated by § 92-1 hereof.
- (24) Allow any dog or cat to run at large. Dogs shall be permitted, provided that they are restrained by a leash not exceeding six feet in length and let or controlled by a person capable of controlling said dog. Dogs shall be prohibited on playground areas at

- all times and on athletic playing fields whenever they are in use. [Amended 12-10-1998 by Ord. No. 12-98]
- (25) Allow any dog under the ownership or control of such person to defecate without immediately removing such defecation and disposing of it in a refuse container or in some other sanitary manner.
  - (26) Drive or park any motor vehicle, including minibikes, snowmobiles or other power-driven equipment, on borough property as contemplated by § 92-1 hereof without permission of the Borough Council. Borough maintenance vehicles and those of borough officials and employees and emergency vehicles shall be permitted.
  - (27) Swim, wade or otherwise go into any body of water within the parks, playgrounds and recreational areas of the Borough of Riverton except in accordance with the rules and regulations relating to the use thereof. No power-driven boats of any type shall be permitted on any body of water within the parks, playgrounds and recreational areas.
  - (28) Utilize the public parks, playgrounds and recreational areas other than during daylight hours. [Added 11-9-1995 by Ord. No. 13-95]
  - (29) Possess or break glassware, glass bottles or glass containers. [Added 11-9-1995 by Ord. No. 13-95]
  - (30) Roller-skate, skateboard or in-line skate on areas such as tennis courts, basketball courts and on or about playground structures. [Added 11-9-1995 by Ord. No. 13-95]
  - (31) Litter. [Added 11-9-1995 by Ord. No. 13-95]
  - (32) Erect tents or canopies without first having obtained the permission of the Borough Council. [Added 11-9-1995 by Ord. No. 13-95]

**§ 92-4. Minors.**

No parent, guardian or custodian of any minor shall knowingly permit or allow said minor to do any act prohibited by this chapter.

**§ 92-5. Use of facilities by organizations.**

- A. Organizations desiring to use park facilities on a group basis will make applications, in writing, to the Clerk thirty (30) days prior to the date desired. Applications shall be available at the Borough Municipal Building.
- B. Organizations utilizing facilities are responsible for the care of equipment and grounds utilized and the cleaning of the area at the completion of the event.
- C. Organizations utilizing park areas must present proof of liability insurance covering injuries to participants during the period the facility is being used, in amounts as determined by the Borough Council based upon probable risk.
- D. Organizations utilizing the park areas will be responsible for the coordination of traffic control and parking with the Borough Police Department.
- E. The Borough Council shall have the right to refuse or cancel the use of any facility to organizations or individuals for reason of repair, construction or other reasons that may be detrimental to the care and upkeep of the area.
- F. The use of posted baseball fields will be by approval of the Borough Park and Recreation Committee.

- G. Organizations utilizing park areas shall be responsible for any and all damage to the park caused by the organization or its guests arising out of their event.  
[Added 11-9-1995 by Ord. No. 13-95]

**§ 92-6. Enforcement.**

The provisions, prohibitions and requirements of this chapter shall be enforceable by state and borough police and supervisory personnel designated by the Director of Parks and Recreation.

**§ 92-7. Construal of provisions.**

The provisions of this chapter are in addition to and not in repeal of, except where inconsistent herewith, otherwise applicable requirements, prohibitions and provisions of law.

**§ 92-8. Violations and penalties. [Amended 11-9-1995 by Ord. No. 13-95]**

Any person who shall violate any provision of this chapter shall be subject to a fine of not more than one thousand dollars (\$1,000.) or imprisonment for not more than ninety (90) days or a period of community service not exceeding ninety (90) days or any combination thereof in the discretion of the Municipal Judge.
