**ORDINANCE NO. O-2022-01**

**AN ORDINANCE OF THE BOROUGH OF RIVERTON, IN THE COUNTY OF  
BURLINGTON, STATE OF NEW JERSEY TO CLARIFY CERTAIN  
PROVISIONS OF BOROUGH CODE CHAPTER §74 ENTITLED “GARBAGE  
RUBBISH AND REFUSE” OF THE BOROUGH OF RIVERTON**

**WHEREAS**, the Borough of Riverton (the “Borough”) has elected to implement the use of the trash carts which will facilitate a more efficient process of trash pick up within the Borough;

**WHEREAS**, the Borough will provide a single trash cart to each property address identified by block and lot in accordance with the official tax assessment records of the Borough of Riverton in order to implement the new automated trash cart pick up system; and

**WHEREAS**, the Borough wishes through this Ordinance to clarify certain provisions with Chapter 74 in order to facilitate the automated trash cart system.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE  
BOROUGH OF RIVERTON, IN THE COUNTY OF BURLINGTON, STATE OF  
NEW JERSEY, THAT:**

1. Section 74-8 of the Code titled “Definitions” shall be revised the definition of trash cart as follows:

**TRASH CART**

A type of cart like container provided by the Borough to each property address identified by block and lot in accordance with the official tax assessment records of the Borough of Riverton as either a thirty-two (32), sixty-four (64), or ninety-six (96) gallon reciptical which shall be used solely by the Borough’s property owner(s) to make trash available for automated pick-up.

2. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Council hereby declares it’s intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Borough to meet the goals of the Ordinance.
3. This Ordinance shall take effect upon passage and publication in accordance within applicable law.
