BOROUGH OF RIVERTON ORDINANCE #8-2024

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF RIVERTON, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING CHAPTER 123, ARTICLE II AND ARTICE III, SCHEDULE IV TO PROVIDE TIME LIMITES FOR PARKING ON VARIOUS STREETS

WHEREAS, the Council of the Borough of Riverton have received recommendations from the Riverton Police Department and the Public Safety Committee that time limits be established for parking on the northeast side of Howard Street between Broad Street and the driveway of the Riverton Fire House; and

WHEREAS, the Riverton Police Department and Public Safety Committee have recommended that the Governing Body further have the authority to regulate time limit parking on a daily basis.

NOW, THEREFORE BE IT ORDAINED AND ESTABLISHED by the Council of the Borough of Riverton, County of Burlington, State of New Jersey that:

1. §123 Article II, Section 10 is hereby amended as follows:

§123-10 Parking Time Limited

No person shall park a vehicle for longer than the time limit shown in Schedule IV (Section123-26) at any time between the hours listed in said Schedule IV of any day upon any of the streets or parts of streets described in Schedule IV attached to and made ap part of this Chapter.

2. §123 Article VIII, Schedule IV is hereby amended to provide for time limit parking at the following additional location and times:

§123-26. Schedule IV: Time Limit Parking Certain Days

In accordance wit the provisions of Section 123-10, no person shall park a vehicle for longer than the time shown upon any of the following streets or parts of streets:
