### Don't Forget!

Environmental best practices suggest leaving some or all of the leaves on your property in the fall and through the spring. Leaves are great, free mulch and fertilizer, and they provide habitat for beneficial insects and other wildlife. They even help trap carbon and prevent it from turning into carbon dioxide (which contributes to global warming). If this practice is new to you (and that's OK – it is new to many of us!), consider leaving the leaves in one or two garden beds. Of course, if you have excess leaves, the Borough will pick them up as usual. You can read more about the benefits of leaving the leaves here. Also be sure to leave your stems in the winter instead of pruning them or cutting them down. They provide important habitat for overwintering insects and other beneficial critters. Let us know if you have questions.

If you do move or remove some of your leaves, avoid using gas-powered leaf blowers. They pollute the air and contribute to global warming.

<u>According to the Association of New Jersey Environmental Commissions</u>

(ANJEC), "Gas Leaf Blower emissions for 30 minutes are equivalent to the CO 2 produced by driving a truck from Anchorage to Houston." Yikes! You

Please also keep in mind best practices in salting your sidewalks this season. To balance safety with environmental needs, experts encourage us to use less road salt than we often do. Did you know that you only need about a coffee mug's worth of salt for the average twenty sidewalk squares?
