

**BOROUGH OF RIVERTON  
ORDINANCE #3-2025**

**AN ORDINANCE OF THE BOROUGH OF RIVERTON,  
IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY,  
AMENDING CHAPTER 94 OF THE CODE OF THE BOROUGH OF RIVERTON  
ENTITLED "PEACE AND GOOD ORDER"**

**WHEREAS**, Chapter 94 of the Code of the Borough of Riverton (the "Borough") entitled "Peace and Good Order," sets forth miscellaneous public safety provisions that have been determined to be in the best interests of the public health, safety and general welfare of the residents of the Borough; and

**WHEREAS**, the Borough Council has determined that a restriction on sleeping in vehicles within the Borough is desirable and in the best interest of the Borough and its residents; and

**WHEREAS**, pursuant to N.J.S.A. 40: 48-2, the Borough Council is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Borough by law.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Borough of Riverton, in the County of Burlington, and State of New Jersey as follows:

**SECTION 1.** Chapter 94 of the Code of the Borough of Riverton, entitled "Peace and Good Order" is hereby amended, revised, and supplemented to establish a new Article IV, subsection 94-9, entitled "Sleeping in vehicles," as follows:

**§ 94-9 Sleeping in vehicles.**

It shall be unlawful to sleep in any parked motor vehicle or any other type of vehicle, either day or night, within Borough limits.

**SECTION 2.** Existing Article IV, subsection 94-9 entitled "Enforcement; Violations and Penalties" shall forthwith following the date of this ordinance adoption be re-numbered as Article V, subsection 94-10 – Enforcement; Violations and Penalties.

**SECTION 3.** All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**SECTION 4.** If the provisions of any section, paragraph, subsection, or clause, of this amending ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.


**SECTION 5.** This Ordinance shall take effect upon passage and publication in accordance within applicable law.
